2012 Commercial Building Awards

PROJECT SUBMISSION FORM

Eligibility

Investment, commercial or industrial building or renovation projects located within the Vancouver Island Real Estate Board area, and completed between **January 1, 2011 and December 31, 2011** are eligible for a Commercial Building Award.

Judging

Each submission will be judged on the following criteria:

- Investment, commercial or industrial building or renovation projects located within the Vancouver Island Real Estate Board area
- Investment, commercial or industrial building or renovation projects completed between **January 1, 2011 and December 31, 2011**.
- Does it complement the surrounding properties and area?
- Is it esthetically pleasing?
- Are their unique architectural features?
- What is the level of finish (choice in construction materials)?
- Does it answer a specific development need within the community?
- Does it have any environmentally friendly or green elements for possible consideration?

A panel of independent judges, selected at large by VIREB's Commercial Division, will visit each nomination, look at the overall exterior design of the project, and determine how each fit into the surrounding area. Once all sites are visited, the judges will decide the winners.

Judging Categories

Awards are presented under various categories. Categories *may be* adjusted based on nomination response. Past categories have been as follows:

- Mixed use (commercial/residential)
- Industrial
- Senior's Housing
- Multi Family
- Community Institutional
- Retail
- Industrial
- Renovation
- Office
- Community Enhancement
